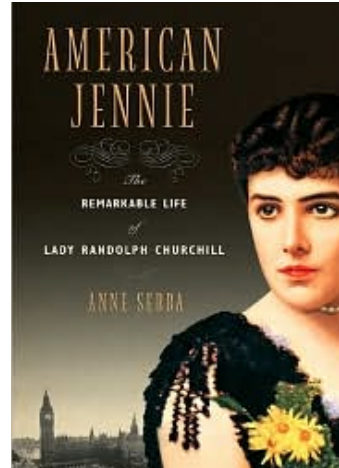

Going Green: How To Make It Work With Preservation

“As LWV members and as citizens, we need to be informed on the important topic of green initiatives.”

*Sunday, February 8, 2009
Lake Forest High School
2:00 – 4:00 p.m.*

The City of Lake Forest and the Preservation Foundation are sponsoring this presentation in which State of Illinois architect Mike Jackson will speak on “Preservation Goes Green” and architect Tom Rejkovich will talk about why older windows refurbished are better than new ones, a subject that is especially relevant for our high school renovations.

Why should these topics interest our League?

In February 2008, the National Trust for Historic Preservation determined that preserving good buildings rather than tearing them down for new construction is far more sustainable for our environment. Their surveys indicated that more than one third of our carbon imprint came from private dwellings, with 29% coming from manufacturing and business and 31% coming from transportation.

Lake Forest and Lake Bluff governments have also fo-

cused upon reducing our carbon footprint. Lake Forest hopes to have this program as the first of several throughout the year that will focus upon “green” initiatives in other aspects of our town life. LWV-US at the National Convention last June in Portland, Oregon focused upon the importance of “green” as one of the major issues to study.

As LWV members and as citizens, we need to be informed on this important topic.
